## **Instructions on Obtaining a Letter of Non-Filing**

To obtain a "Verification of Non-filing Letter" you can go to <a href="www.IRS.gov">www.IRS.gov</a> and click on "Get My Tax Record" and then click on "Get Transcript ONLINE", or you can call 1-800-908-9946. If the IRS has no record of any 2017 tax return being filed under your Social Security Number, then instead of a tax transcript, you will receive a letter confirming your non-filing.

A Letter of Non-Filing must accompany this worksheet if this is the option that you select. A written statement, submission of W2's, or simply checking the non-filing option will not be enough to clear verification
